11. I understand that anyone who cannot truthfully make the certification as set out in subparagraphs 2 through 8 is prohibited by law from possessing a firearm, except as otherwise provided by federal law.
12. I understand that any false certification to, or false information given, on the Annual Range Pass without refund.

### **RANGE OPERATION AND SAFETY RULES**

**Gun safety is important! Please read all of the following safety rules. Please understand that the strict enforcement of these rules is for your safety and the safety of those around you. Infractions of the safety rules can be cause for immediate dismissal from the facility and cancellation of range passes or range time. There will be NO REFUNDS of money for customers that do not abide by the rules and have had their passes or range time revoked.**

#### **Basic Gun Safety Rules:**

1. Consider all firearms to be loaded at all times. Keep the action open and the barrel pointed in a safe direction and unloaded until ready to shoot.
2. Always keep your finger off the trigger and out of the trigger guard until ready to shoot.
3. Always keep the gun unloaded until ready to use.
4. Be sure the gun is safe to operate.
5. Know how to use the gun safely.
6. Use only the correct ammunition for your gun.
7. Know your target and what is beyond the target.
8. Wear appropriate Eye and Ear protection.
9. Never use alcohol or drugs before or while shooting.
10. Store guns so they are not accessible to unauthorized persons.

#### **Additional Eagle 1 Law Enforcement Supply Range and Safety Rules**

1. **ABSOLUTELY NO LOADED FIREARM WILL BE ALLOWED TO ENTER OR EXIT THE FIRING RANGE FACILITY.** All firearms not on the firing line must be unloaded with their action open and the magazine removed, or unloaded and encased. Exception: Sworn Law Enforcement or Concealed Carry Permit Holders whose weapons may be holstered and remain holstered while not on the firing line.
2. All shooters must attend a Range and Safety Orientation Briefing, complete the Eagle 1 Law Enforcement Supply Indoor Range Test, complete and sign the Waiver and Release of Liability, and the Assumption of Risk and Indemnity agreement before using the range.
3. Commands issued by Range Officers and Range Personnel must be obeyed immediately and without question. The Range Officer will have **FINAL** word in **ALL** matters. If the Range Officer feels that you are unfit to use the range for **ANY REASON**, you will be denied access.
4. Do not load your weapon unless you are in the shooting stall (booth).
5. **DO NOT LOAD YOUR WEAPON IN THE STORE WHICH INCLUDES THE SHOWROOM, BATHROOMS AND OTHER AREAS.**
6. Do not exit the shooting stall (booth) with a loaded weapon, except sworn law enforcement or concealed carry permit holders may exit with loaded weapon in the holster. Weapon must remain in the holster while on the premise of Eagle 1.
7. The range is always considered **"HOT"** unless declared otherwise. This means that firing may commence at any time, you are free to handle your firearm and everyone must remain behind the firing line.
8. When the command **"CEASE FIRE"** is given, or the Range Alarm is sounded:
  - Stop shooting **IMMEDIATELY**.
  - Remove your finger from the trigger.
  - Keep the gun pointed in a safe direction.
  - Wait for further instructions from the Range Officer.
  - Anyone on the range may issue a **"CEASE FIRE"** command upon a safety violation or emergency.
9. No one other than Eagle 1 Law Enforcement Supply personnel may go forward of the firing line.
10. When the line is declared **"COLD"**:
  - All firearms must be unloaded and benched with the muzzle pointed down range, the action open, ejection port or cylinder up and magazine removed.
  - Everyone must step back from the firing line and wait for the Range Officers' command.

- No firearms may be handled while the line is “COLD”.
  - The “Continue to fire” or the “Line is hot” command will be given when it is once again safe to shoot.
11. Eye and Ear protection must be applied before entering the range and must be worn at all times while on the range.

### **EAGLE 1 LAW ENFORCEMENT SUPPLY INDOOR RANGE OPERATIONAL PROCEDURES**

1. All federal, state and local firearm laws must be obeyed.
2. Owner of Class III firearms must be in legal possession of both firearms and paperwork required by law. Prior arrangements must be made with the Range Officer concerning Class III firearm use. Certain Class III weapons, firing from open bolt, are “safe” when the magazine is removed, bolt forward.
3. Prior to shooting, a Range Officer will assign you a numbered lane. No one will be allowed to change lanes unless authorized by a Range Officer. If authorized, firearms must be unloaded and cleared prior to changing lanes.
4. All weapons and ammunition must be unloaded and ready for inspection by Eagle 1 Staff prior to range use.
5. PISTOL CALIBER AMMUNITION ONLY may be used on the range. No high powered/centerfire rifle calibers allowed (5.56, 7.62 etc).
6. NO RUSSIAN OR CHINESE MADE AMMUNITION (NORINCO, WOLF, ETC.) Ammunition that contains any steel will not be allowed. Only approved ammunition may be used. Use of this ammunition is a safety hazard. Anyone using this ammunition on the range will be removed immediately and range privileges revoked.
7. No Pistol Grip Shotguns. Only Shotguns with full stocks.
8. When leaving the firing position temporarily, firearm must be left unloaded and in the clear position (action open with the ejection port or cylinder up, magazine removed) pointed down range.
9. Firearms and ammunition must be compatible. Only one firearm and the compatible ammunition are permitted in the booth at one time. Additional firearms (unloaded with the action open) and compatible ammunition may be kept to the rear of the firing position.
10. Use the appropriate size target to ensure that your shots strike the backstop and not the ceiling or target holder. Small targets should be taped to larger targets to minimize the chance of hitting the target carrier. Intentionally firing a shot that results in the bullet striking anything other than the target and/or backstop may result in a damage or repair fine and/or your removal from the range, permanent ejection from the facility and revocation of any passes without refund of money.
11. The shooter is responsible for any abnormal damage to the range. Hitting the ceiling or walls or lights is abnormal damage.
12. Cross firing of targets prohibited.
13. You may draw from a holster and fire only after obtaining authorization to do so from the Range Officer. Only belt holsters, placed on the same hip as the shooting hand, may be used on the range. Shoulder holsters and cross-draw holsters may not be used unless authorized by the Range Officer during designated courses.
14. Controlled Rapid Fire is acceptable:
  - a. Each round must strike the intended target and you must shoot within your abilities.
  - b. Failure to control your fire will result in removal from the range. You will have to pay for cost of repair to the range. You will have to attend our safety course at your expense to use the range again.
15. No firing from kneeling or prone position in the position in the shooting booths. All firing must be from a standing position unless otherwise authorized. You may fire from a sitting position when sighting a firearm.
16. Misfires:
  - Keep the muzzle pointed down range and wait at least 30 seconds before clearing the misfire or notifying a Range Officer.
  - If you need assistance clearing the malfunction, notify a Range Officer by raising your hand. Be careful to keep the muzzle pointed down range.
  - Do not take jammed or malfunctioning firearm away from the firing point, place on the bench with the muzzle pointed down range.
17. You will be required to temporarily surrender your annual range pass and driver license for lane assignments. Upon leaving the range, cards will be returned.
18. Anyone using offensive language, behaving in an unprofessional manner or in any way being a nuisance or distraction to others will be barred from the facility without refund of money.
19. In order to minimize noise in the lobby area, please let the lobby door close completely behind you before opening the range door and vice versa.
20. Eagle 1 Law Enforcement Supply is not responsible for any customer belongings left on the premises.
21. PLEASE, SWEEP UP YOUR BRASS and throw away all trash in appropriate receptacles.
22. If you have read this information in it’s entirety, place a check mark on the bottom right corner of this page.

### **RANGE OCCUPANTS**

1. Person under 18 years of age must be accompanied by a parent or guardian. The parent or guardian must remain with the underage member at all times while in the firing area.
2. Eagle 1 Law Enforcement Supply reserves the right to photograph or videotape all patrons.
3. Food, beverages, physically impairing products and the use of tobacco products are prohibited on the range. Smoking is prohibited throughout the building.
4. Lead is a poison, so for your safety, always wash your hands and face immediately after shooting and/or cleaning your firearm.
5. Only one person is permitted to shoot from a firing lane at a time. Not more than two people will be assigned to a firing lane.
6. **NO SPECTATORS ARE ALLOWED INSIDE THE RANGE AREA.**

**RANGE USER AGREEMENT, LIABILITY RELEASE, AND ACKNOWLEDGEMENT OF RISK**  
For All Participants and All Observers

In consideration of the services of Eagle 1 Law Enforcement Supply, Inc. , their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as " EAGLE 1 "), I hereby agree to release and discharge EAGLE 1, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

I, \_\_\_\_\_, acknowledge that target practice at a shooting range entails known **and** unanticipated risks which could result in serious physical or emotional injury, paralysis, death, dismemberment, or damage to myself, to property, or to other persons.

**The risks include, but are not limited to:**

1. Participation may result in the undersigned or other persons being shot by a firearm; suffering hearing loss; eye injury or loss; inhalation or contact with airborne contaminants and or flying debris, slipping or falling on uneven or loose terrain, and hazards associated with an indoor firing range. Furthermore, EAGLE 1 employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They may give inadequate warnings or instructions, and the equipment being used might malfunction.
2. I further certify that I have no medical, mental or physical conditions which could interfere with my safety in this activity, or if such conditions exist, I have made an informed judgement that they are minor, and I am willing to assume the risks that my conditions create, directly or indirectly, and bear the costs and responsibilities for those conditions.
3. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
4. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless EAGLE 1 from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of EAGLE 1's equipment or facilities, **including any such Claims which allege negligent acts or omissions of EAGLE 1.**
5. Should EAGLE 1 or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
6. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage to myself or others.
